Follow up Letter: Members of Parliament, Senators and Supreme Court Justices

On May 28<sup>th</sup>, 2012, I sent correspondence responding to further threat and intimidation from my federal employer at the Matsqui Institution in Abbotsford, British Columbia, Canada. My correspondence, at that time, was directed to every Canadian Member of Parliament, Senator and Supreme Court Justice. Following that correspondence, the situation escalated into an investigation in which I was to be sanctioned for improper conduct. It began as a fully activated federal investigation for a period of time after which it became a dormant issue without any notification from management.

Being aware of support extended in these matters over the years, I would like to acknowledge my gratitude towards everyone who continues to oppose the corruption that has been brought to your attention during my federal employment. This support has been greatly appreciated in my efforts to expose criminality in government and the Canadian justice system. Over the many years of doing this it should be recognized that these are not just Canadian issues but international issues involving many nations including even the Israeli government and their judicial system.

As an extension in bringing these issues into public notice the signage seen below was attached to my car in May of 2013.



After more than a year, response to this signage far exceeds all expectation. On a daily basis, people are taking note of the CTMin website information, in addition to public interaction several times a week. I would estimate support at 90%, with very few occasions where some form of displeasure was expressed. Following one particular exchange, the person involved apologized upon taking further consideration and an examination of the evidence. This estimation of support is based upon actual interaction.

Although it is not my expectation that this criminality and corruption will be effectively dealt with I do believe that exposing it is a public service providing notice that subversive activity has been made known in the public domain. It has been often noted that corruption loses much of its power when exposed to the light of public scrutiny.

Over the years, there are also those who have reconsidered their involvement within the secret societies, based upon the evidence, choosing to turn from a deadly deception. This aspect of providing a choice between truth or lies is a primary factor in every resource developed for the Choosing Truth

Ministries website<sup>1</sup> so that those in various forms of bondage would be aware of choices. Another important aspect in many CTMin resources is to provide a warning of the spiritual dangers involved in things like the secret societies. Most Masonically affiliated people, like my grandparents, were good people involved in these things based upon a succession of lies and secrets carefully hidden from all of us who were ever involved in the secret societies. My grandparents along with 90% of all members would never have joined if we had known the truth.

One of the more interactive incidents took place in July 2013. As God often does, He provided a witness in my car who testified to having been a part of the interaction with the RCMP officer in all that transpired. She gave a full and complete report of everything that had transpired an hour later at the Bible study we were on our way to attend.

The following is a brief summary of what had taken place after having spent the day at one of our beaches on the west coast of British Columbia. We left with enough time to drive to our evening meeting. Shortly after leaving, I was aware of an RCMP cruiser following us for eight to ten kilometres and assumed that it had something to do with the signage seen on the previous page. Coming to a safe stretch of roadway, we were signalled to pull over. Due to the exchange that took place, I am able to commend the RCMP and this police officer for the integrity that was exercised in his position of authority. This police officer had taken the time and the initiative to pull us over to express his appreciation for taking a public stand of support for Israel, as well as being a resource provider in exposing the secret societies, such as Freemasonry. We spoke, sharing back and forth with this officer for a period of time. Even with the extra travel time we had given ourselves, we ended up being half an hour late for our meeting, but we had this experience to share which was gratefully received.

This support for Israel is, of course, a reflection of the support extended by our federal government under Prime Minister Stephen Harper. Under his leadership, our nation has been blessed by God according to His promise to do so in Scripture, “And I will bless those that bless you, and curse those that curse you, and in you shall all the families of the earth be blessed.” Genesis 12:3.

Over the past few years, we have attempted to expand our outreach on social media using Facebook. Back in December 2012, despite a new round of condemnation towards Israel for defending itself, our nation stood as a friend to Israel under Prime Minister Stephen Harper. At that time, in support, we shifted our attention from Freemasonry to highlight Stephen Harper’s support for Israel. In doing these kinds of things on our website, Facebook, and even the signage on my car, I am greatly impressed by the expression of public support for Israel that continues to be received. This public support is, of course, largely credited to Stephen Harper and the Conservative government.

As to the signage regarding Freemasonry, I have been surprised by the large number of people who are either aware of Freemasonry’s deceptive nature or aware that something is not quite right about this organization. Many people are naturally concerned by the secret societies that keep secrets from the public knowing there is something wrong in the need to do these kinds of things. Faced with public criticism, Masonic authorities responded by stating, “We are not a secret society but a society that has secrets.” Keeping secrets from Masons in the lower Blue Lodge degrees has always been necessary to maintain a membership throughout every level of society.

Every Mason swears total obedience to the Masonic Lodge on his very first night. It’s part of

the “solemn obligation” that binds every Mason together within the secret societies. Masons are expected to commit perjury and other forms of criminality as honourable activity under their Masonic obligations. In exchange, members receive the ‘benefits of Lodge membership’ — job promotions, government contracts, and access to public funds without any accountability other than to the political powers within the secret societies. Despite the charity being promoted, it’s all designed to distract public attention from the political abuse of power by the secret societies. Even Christian Masons don’t seem to ask questions under their Masonic obligations except for those who end up leaving when the truth has been revealed to them. These obligations that bind Masons into obedience can be seen in our manual, *The Court System And Freemasonry*.<sup>2</sup>

With the display of this signage, additional opportunity has been provided to speak with Blue Lodge Masons, the first three entry level degrees. Although there are many higher levels, or degrees, most Masons never proceed past this Blue Lodge entry level or learn the true nature of Freemasonry carefully hidden from them and the public. We emphasize in our resources that most Masons are honest, sincere, and productive members of our communities — good people including members in the Christian church community, despite their Masonic affiliation under its deception.

The membership is mostly made up of people who obey their obligations and don’t ask questions. People join with good intentions to engage in charity, socialization, and/or for the unity found within the Lodge. Many, like myself, may have initially believed that Christian beliefs and Freemasonry were compatible. Upon researching the higher levels comes a recognition that the authority operating within Freemasonry is in direct rebellion to God and to everything spoken by Him in Scripture. Once this is understood, a choice has to be made as to who is more important – Jesus or the Lodge.

For most of us, in choosing to leave the Lodge, the issue was not separation from Masonic brethren, but separation from an organization under the Luciferian doctrine upon which the secret societies derive their authority. In one of our articles<sup>3</sup>, we have taken quotes written by some of the most highly regarded authorities in Scottish Rite Freemasonry. Two of these 33<sup>rd</sup> degree Masons clearly identify Lucifer as being the god of Freemasonry, also called The Great Architect Of The Universe, The GAOTU.

Recently, one of my friends made his decision to leave the Lodge when he began to understand that Freemasonry created a spiritual barrier between himself and God. Faced with the decision of what was more important to him, he chose to place his complete trust in Jesus rather than to rely upon the Masonic promise of salvation through the good works of the Lodge. This is the same choice that every Mason will have to make upon being informed about the truth concerning Freemasonry. Until being informed, making a decision to submit to God, the Mason has been deceived into placing himself and his family members under a deadly deception.

In dealing with men who have a level of Christian conviction, these members are led to believe that the GAOTU is either the God of Israel, or God by whatever name He might be called in another faith. To clarify this deception, one of the things I point out to Masons is the relationship between God and Jesus. Of all the religious assimilation within the Lodge, there are official Masonic sanctions

applied to Jesus. One of them stipulates that prayer offered up in the Lodge cannot end in His name. It is explained that this might be offensive to other faith groups within the Lodge membership.<sup>4</sup>

While this may, at first, sound reasonable to a Mason, after having undergone the initiation rites as also noted in our article *First Lodge Night*, there is the question that I ask Masons: If God (Yahweh) truly was this Great Architect Of The Universe, how could prayer in the name of His only begotten Son be offensive to Him? Especially when He makes it clear that Jesus (Yahushua) is the only way to Himself, the Father? When YHWH clearly states, in His Word, that there is no other name under the heavens by which any person on this Earth can be saved, then it must be asked who this GAOTU really is. These questions and dialogue help many Masons to start asking themselves the same kind of questions. For many Masons, this often leads to research in their journey out of Freemasonry.

Throughout Freemasonry, there are clues as to the identity of this Great Architect Of The Universe. The Shriners, seen wearing their red hats in parades, etc., are a prestigious branch of Freemasonry in North America. The red hat worn by the Shriners is called a Fez for a very significant reason.

Conclusive to this subject, Reverend Mick Oxley, a World War II veteran who spent 35 years in the Royal Air Force, offers vital information about the Shriners. He served as personal air crew for British Prime Ministers and other dignitaries around the world, finally retiring as a Wing Commander. During his military career, he had the opportunity, in his assignments in the Middle East, to learn many things about Islam.

It has been one of my greatest pleasures, having had the privilege to know Mick Oxley in our ministry association over many years. Like myself and a multitude of others, Rev. Oxley left Freemasonry after realizing he had to choose between Jesus and the Lodge. Rev. Oxley founded In His Grip Ministries and wrote the following in a book he co-authored with his daughter:

### **The Mystic Shrine<sup>5</sup>**

It was after we moved to America that I first encountered the Mystic Shrine, or to give this American degree its' full name, "The Ancient Arabic Nobles of the Mystic Shrine." This is a purely American degree, which indeed would not be tolerated by British Freemasons. This is an adolescent degree of childish behaviour and wild parties including blasphemies which serves as its ritual. The solemn obligation is utter blasphemy in which the candidate takes the oath of a Muslim and declares Allah, the god of Arab, Muslim, and Mohammed to be "the God of our fathers." It is obvious that Allah is not the God of the Bible because Allah does not have a son.

Allah is actually a demon spirit as are all gods worshipped in all other pagan religions.

Other elements of the Shriners' ritual have been recognized for what they are by

Anton LaVey, in his book, *The Satanic Rituals*<sup>6</sup>. LaVey describes himself in the book as one of the Devil's most devoted disciples. He also wrote *The Satanic Bible*<sup>7</sup> and was founder of the California based Church of Satan.

In "The Satanic Rituals", LaVey describes one of the rites of Lucifer, called L'Air Epais<sup>8</sup>. In English, it is translated as The Ceremony of the Stifling Air. LaVey writes: "A striking American parallel to this rite is enacted within the mosques of the Ancient Order of the Nobles of the Mystic Shrine, an order reserved for thirty-second degree Masons. The Nobles have gracefully removed themselves from any implication of heresy by referring to the place beyond the Devil's Pass as the domain where they might worship at the shrine of Islam."

It really makes little difference whether one worships Allah or the Devil. Both are demonic. While I watched the Shriner's parade for the first time in America, I saw the Fez. I was horrified. I immediately remembered the teachings about the Fez given by the Mullahs which my friends had repeated to me in Egypt. The Mullahs had bragged of the Muslim hordes which had driven thousands of Christians across the northern part of Africa to the city of Fez, Morocco.

They bragged that at Fez, the Muslims took revenge for their losses during the Crusades by executing fifty thousand Christian men, woman and children. The Mullahs said that even unborn babies were murdered, being removed from the wombs of their mothers, and having their heads, arms and legs hacked off with a scimitar, a large sword with a curved blade. They boasted that the blood of the slaughtered Christians was running deep in the streets of Fez and the Muslim executioners dipped their white hats into the Christians' blood and proudly placed the now blood-red hats on their heads as symbols of their triumph. These red hats were known as Fezes from that time forward.

I was deeply grieved to see the Shriners proudly wearing this red Fez. They also were displaying the Muslim emblem of the crescent moon and star along with the emblem of the scimitar which was used to put to death these thousands of Christian men, women and children in Fez, Morocco- the same scimitar that the Mullahs also said would ultimately be used against all kinds of infidels throughout the world who do not bow down and worship Allah. God must look upon the Shriners with utter disgust and loathing as they parade around like stupid schoolchildren.

### **Masonic Influence in England**

I know that in English Freemasonry, the blood oaths in the first three degrees and

in the Royal Arch degree have now been removed. Do not be fooled! I renounced English Masonry because I knew it was evil. I knew it had occultic overtones. Because of my experience in Eastern Mysticism, I was not just uncomfortable being a Mason; my spirit became absolutely distressed.

Since renouncing Freemasonry, I have become aware of the hidden spiritual forces of darkness and the subversive political influence of Masonry. I have reviewed the different church pronouncements concerning Freemasonry. Many of those studies in England and Western Europe have been performed independently from one another.

This adds credibility to the unanimous conclusion that Freemasonry is in reality an instrument of deception by our adversary, Satan. It is without question one of his most successful and formidable accomplishments.

It became quite apparent to me how Masonry has influenced Great Britain, in particular through the agency of the police. Scotland Yard was unduly influenced by Freemasons who held high positions. The Metropolitan Police and the Justice System have also been taken captive by Freemasonry. Justice has not been applied equally to Masons and non-Masons. This has been reported in several books, including *The Brotherhood*<sup>9</sup> and *Inside the Brotherhood*<sup>10</sup>. Both of these books are sold in England.

In the above, it was stated by Anton La Vey that the Mystic Shrine is an order reserved for 32nd degree Masons. This was true many years ago, but has since been changed to accommodate various businessmen, judges, etc, who don't have the time or interest in becoming 32nd degree Masons. For many decades now, membership in the Shrine has been open to the lower degree Blue Lodge Masons.

To be blunt, it also needs to be recognized that many of these men do not possess the mental capacity for the memory work and other requirements involved in becoming upper degree Masons. The positions and power that most Masons attain is purely by Masonic appointment and patronage well beyond their personal levels of competency. This has led to both incompetency and criminality within the government<sup>11</sup> as well as within the supervisory structure of the Canadian RCMP<sup>12</sup> reflecting the same

levels of criminality that became rampant in Britain's Scotland Yard.<sup>13</sup>

Although this aspect of Masonic patronage has created compounding levels of incompetence throughout every federal department in the Canadian government, there are, by God's grace, exceptions. Sir Winston Churchill is one of these exceptions. God was able to use him in the impossible defence of Great Britain and western democracy during WWII. However, it should be recognized that Churchill resigned from Freemasonry prior to his death. The Grand Lodge of Britain in London, England, is the Mother Lodge for British Freemasonry; it does not acknowledge that he renounced his Masonic membership. For a brief time, a notation attesting to this was in his biography in the London Museum but was removed when reports of this were made known publicly.

Unfortunately, for every nation that tolerates Masonic patronage, incompetency and criminality will be major factors in how well each nation will be able to conduct its national and international affairs. Currently Israel has experienced some difficulty in its ability to defend itself more effectively due to these issues. For Israel, more than any other nation, this becomes a factor impacting its existence reliant upon the God of Abraham, Issac and Jacob. Tolerating Masonic idolatry is the same idolatry allowed into Israel leading to judgement on several occasions. It is the same idolatry found in America being brought into Israel.

Also, although Rev. Oxley stated that the Shriners are strictly an American Masonic Order, I recently learned from an Israeli that this is no longer true. It is now practised by Jewish Masons in Israel. Initially, I was greatly perplexed until realizing it is the American Jews who are bringing this idolatry into Israel. As has been noted throughout the history of the Hebrew people in the Scriptures, God does not tolerate this forever in Israel, nor will He in any other nation upon the Earth.

Originally imported from an Islamic nation; the mystic shrine is the shrine of Mecca, where Allah is being worshipped by Muslims and Shriners. Shriners are told that Allah is simply another name for the GAOTU, representing the god of Freemasonry by whatever name chosen to call him. However, by comparing the attributes of Yahweh, the God of Abraham, Isaac, and Jacob, with the attributes of Allah, it is seen that they are not the same and are in fact totally opposed to each other.

Throughout Scripture, YHWH professes His all-consuming love towards Jews and Gentiles, having provided a way in which all mankind may enter into His Kingdom. Allah, on the other hand, in the Koran, commands his followers to kill all Jews and Gentiles who refuse to convert to Islam except for those selected for use as slaves. Written in the Koran, it becomes obvious that this GAOTU, Allah, Lucifer, or whatever name chosen to call him, is not the God of Israel speaking to us in His Word. Yahweh, the God of Abraham, Isaac, and Jacob, is consumed in His love for each of us, while the other is consumed in his hatred for humanity, having created things like Freemasonry to deceive good men and their families away from God's mercy and grace.

When we begin to understand the true nature of Freemasonry, one of the things we need to keep in mind is that most Masons are good people under a deadly deception. Thinking of these men and their families under these conditions is where we are required to walk in an attitude of compassion, rather than that of condemnation. When condemnation drives people away from truth, there is no victory in Him.

However, as noted in our article *The Church And Freemasonry*<sup>14</sup> there are times in which the church will be required to take an aggressive stand against Masonic intrusion to defend itself and doctrinal integrity.

John Daniel provides information regarding the 1926 orders from the Supreme Council of Scottish Rite Freemasonry at Charleston, South Carolina, telling Masons in America to join the Christian churches.<sup>15</sup> After these orders were published in the New Age Magazine, now called The Scottish Rite Journal, Masons throughout the United States joined their local Protestant churches working their way into leadership positions. This enabled the Supreme Council to dictate Masonic agenda in the evangelical churches of North America. Prior to this 1926 infiltration, the Protestant churches in America stood firm publishing warnings exposing Freemasonry to church members and the public. Infiltration of the Protestant church became one of the methods used to silence churches globally.

From historical perspectives, it has been estimated that 90% of all Masons would leave the Lodge, if they understood what Freemasonry really is. This occurred in America as a result of the murder of Captain William Morgan in 1826<sup>16</sup>. Following a deathbed confession from one of the Masons involved in his murder, it is estimated that 90% of all Masons quit their Masonic membership. This historical account confirms that good men will respond accordingly when they understand the truth about Freemasonry.

We all face choices; some are more important than others. As much as possible, choices should be based upon reliable information. In His Word, God encourages us to challenge Him to prove that He is who He claims to be. For those who require proof of His existence, He offers evidence based upon Himself. In Scripture YHWH goes beyond providing proof of His existence in telling us to challenge Him in this. He has promised to respond to those sincere in their desire to know Him, those who would serve a true and living Elohim.

Every Mason is required to believe in a Supreme Being or deity of his choice. As noted the god of Freemasonry is called The Great Architect Of The Universe in the lower degrees and also known as Lucifer among other names in the higher degrees. In the New Testament book of Colossians, chapter 1, we are specifically told that Jesus (Yahusuha) is the Creator of all things in the heavens and on Earth, visible and invisible. Yet in the Lodge, in worship of the GAOTU, Jesus, the Creator of all things has been rejected. A Bible placed upon a Masonic altar cannot be opened beyond Malachi, the last book of the Old Testament. This would violate Masonic protocol to acknowledge Jesus by opening Scripture in the New Testament. Under Luciferian doctrine, the Masonic Lodge has rejected the Creator while choosing to give worship in agreement with the architect of a rebellion against YHWH.

This issue is so critical to the eternal security of every Mason that Choosing Truth Ministries was founded in 2001 to expose the deadly deception of Freemasonry with its false promise of salvation leading Masons down a path to destruction even affecting family members. For the past eleven years CTMin has set up a booth display under Missions Fest Vancouver and the World Trade Centre
